The e-visa takes effect from the date of issue and is valid for 30 days, during which you can make one return trip to Leningrad area, St. Petersburg (including Vyborg and Karelian Strait) or Kaliningrad for a maximum of 8 days.

The process is following

- 1. Carefully fill in the visa application submission service form (see under). It is important that you answer all questions in the service form to avoid your e-visa to be delayed / denied due to incomplete information. Save the document.

- 3. Whit the help of these documents we will start the process. The e-visa will be issued within 2 6 days after we have submitted your online application. We will send the ready e-visa to you according to your oder.

Service fee and payment

Our service fee 35 eur can be paid in advance (by a payment link sent to your email), at our office or online in Paytrail payment service. We charge the corporate customers according to the agreement.
